

















Advanced Professional Development Program

Advanced PDU's is a district-centered program option* for moving from the Preliminary Teaching License to the Professional Teaching License. The Advanced Professional Development Program is:

- Developed jointly with the applicant and the employing district or public school.
- Based on the employing school district evaluations of the applicant.
- Aligned with the annual performance goals of the applicant.
- Accompanied by an overall proficient level rating (3) on the annual performance evaluation for all years of the program.
- Specifically tailored to provide the applicant with the appropriate skills to advance the applicant from novice to professional skill level
- Made up of at least 150 Advanced Professional Development Units (PDU's). A minimum of 30 Advanced PDU's must be completed in each of the four domains per license renewal period.

Completion of the Advanced Professional Development Program must be accompanied by four full years, or six less than full years (.5 to .99 FTE) of teaching experience, as verified on PEER forms to TSPC.

Where PDU limits are provided for the program, they are intended to be for the entire plan and not for the individual domains.

Examples provided are intended to serve as guidelines, they are not intended to limit advanced professional development opportunities or to serve as an exhaustive list.

*Please note advanced PDU's are only portable between the above-named districts. Districts outside the consortium maintain full discretion regarding the acceptance and final approval of advanced PDU's earned in this program.

The Advanced Professional Development Program must be pre-approved by your supervising administrator and by Human Resources. Once completed, the program must be verified and approved by the supervising administrator and submitted to Human Resources.

Human Resources will complete and submit the required "Advanced Professional Development Program/Advanced Teaching Experience Professional Teaching License Completion Report Form" to Teachers Standards and Practices Commission (TSPC).

It is the responsibility of the educator to maintain back up documentation verifying all advanced PDU's as it may be requested by TSPC.

- Teaching extended school year, summer school, migrant education summer program, credit recovery, and/or zero periods, in addition to your regular assignment (limited to 10 PDU's)
