## LGBTQ+ PRIDE MONTH PROCLAMATION

**WHEREAS**, Pride Month celebrations include people who are Lesbian, Gay, Bisexual, Transgender, Queer, Two-Spirit, Pansexual, Asexual, Genderfluid, Nonbinary, Intersex, as well as heterosexual and cisgender allies; and

**WHEREAS**, the New York City police raided the Stonewall Inn, a gay club located in Greenwich Village in New York City and sparked a riot, leading to six days of protests and violent clashes with law enforcement known as the Stonewall Riots<sup>1</sup>, which later served as a catalyst for the gay rights movement in the United States and around the world; and

**WHEREAS**, Portland has a rich history of LGBTQ community leaders, including activist and founder of Portland's first Pride march Kathleen Saadat<sup>2</sup>, judge and Asian Pacific Islander Pride co-founder Lynn Nakamoto<sup>3</sup>, founding board member of Portland's Q Center and PDX Latinx Pride David Martinez<sup>4</sup>, and founder of the Portland Two Spirit Society Amanda Brings Plenty-Wright<sup>5</sup>, among countless others; and

**WHEREAS**, we must acknowledge that the LGBTQ community has faced and continues to face systematic discrimination including restricted rights, social stigma, challenges accessing healthcare<sup>6</sup> and other basic social services<sup>7</sup>, and startling rates of violence<sup>8 9</sup>; and

**WHEREAS**, 5% of DDS high school and middle school students<sup>10</sup> reported that they identify outside of the gender binary, and, there are an estimated 150,000 transgender youth nationwide between the ages of 13 and 17<sup>11</sup>. However, more than half of all trans and gender expansive youth reported they had no access to a school restroom that matched their gender identity, and only 1 in 3<sup>12</sup> were always called their true name while at school; and

**WHEREAS**, according to a recent DDS D survey nearly 1/4 of middle school students 25% and 1/5 20% of high school students do not identify as straight. Despite the size of these groups, lesbian, gay, and bisexual students at DDS D high schools and middle schools, were twice as likely to report having been bullied in the past year, and gay or lesbian high school students in particular reported twice as much physical bullying as other students; and

**WHEREAS**, 20% of students at DDS D middle and high schools reported being bullied and harassed because of their gender and 34% of students at DDS D middle and high schools reported being bullied and harassed because 'Because people think I'm gay (whether I am or not)'; and

**WHEREAS**, schools in our district run groups that support the social and emotional needs of our LGBTQ students, including Pride Clubs at our high schools and middle schools. These clubs work to promote LGBTQ inclusion in schools, such as gender neutral bathrooms; and

**NOW, THEREFORE**, I, Andrea Valderrama, Chair of the David Douglas School Board of Directors, do hereby proclaim June 1st through June 30th, 2020 to be

**LGBTQ+ PRIDE MONTH**  
in the David Douglas School District.

**BE IT FURTHER RESOLVED** that the David Douglas School Board of Directors strongly encourages our staff and community to observe, recognize, and celebrate the contributions of LGBTQ+ people to our country, our state, our cities, and our schools.
